This is with reference to school application No. IS-04618-2425 dt. on the subject cited above.

Sl. No.	GENERAL CONDITIONS
1.	The total number of section of the school shall be restricted to 55 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2.	Compliance of the points no. 1 to 4 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.
Sl. No.	CONDITIONS FOR COMPLIANCE
1	School has uploaded land certificate dated 11/05/2012 having land area 15350 sq mts however, as per Circular no.16/2023 dated 28.04.2023 land certificate should be issued not more that 01 year before the date of application, therefore, School is required to upload Land certificate having land area 15350 sq mts issued by DM/ ADM/ SDM/ Tehsildar/ Naib Tehsildar/ Registrar/ Sub Registrar/ Equivalent Land Authority STRICTLY as per Appendix-X of Circular no.12/2022 dated 14.10.2022 clearly depicting the details of actual owner of land with registration details (By Sale Deed/Conveyance Deed/Gift Deed/Allotment letter etc) and who further leased the land to school/society/trust; under Mandatory Public Disclosure Icon on its website within 03 months from the date of approval of this application.
2	School is required to upload the Building Safety Certificate with validity period issued by Assistant Engineer and above rank officer of Govt. Department STRICTLY as per Appendix-XI of Circular no.12/2022 dated 14.10.2022 clearly depicting the details such as number of blocks and number of floors in each block running in the school; under Mandatory Public Disclosure Icon on its website within 03 months from the date of approval of this application.
3	School shall ensure renewal of other essential certificates time to time and upload them on school's website under the "Mandatory Public Disclosure" icon.
4	School shall ensure section teacher ratio of 1:1.5 excluding principal, physical education teacher and counsellor, to teach various subjects and appoint qualified trained teaching staff on regular basis as per the provisions laid down in Affiliation Bye-Laws, 2018.

In this connection, I am directed to convey approval of the Board to permit increase of sections in the school and subject to strict adherence to the other provisions of Affiliation and Examination Bye-Laws of the Board & appendix V of Affiliation Bye-Laws as well as the following specific conditions:

1. The school is permitted to run () total number of sections. In case of Senior Secondary level 1/3rd of the total sections permitted can be run in Class XI & XII.
2. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
3. The school is required to renew Water & Health Sanitation, Building Safety and Fire Safety certificates on regular basis.


The school will ensure adequate teaching staff and other physical facilities in the school for the smooth functioning with its enrolment.

5. The school will adhere to Rule 14.12 of Affiliation Bye laws of the Board and maintain optimum strength of 40 students in a section.
